This form must be completed and signed when decommissioning a wood-burning fireplace and is also required for new electric heat pump applications. "Decommissioning", for the purpose of this Program, means permanently rendering inoperable.

- The District requires the use of a state licensed contractor when doing work related to the decommissioning of the wood-burning fireplace. The contractor must complete a Fireplace Decommissioning Contractor Certification Form (will be included with the voucher packet). I understand that I will not be reimbursed for any work performed by an unlicensed contractor.
- I assume all the risk and outcome of the fireplace decommissioning work completed for this project. I understand that I am responsible for obtaining all necessary permits and completing required inspections to ensure the project meets federal, state and local requirements.
- I understand that if I currently have a freestanding stove or fireplace insert, I am responsible for obtaining a dated receipt from a dismantling/recycling facility as proof of destruction. Freestanding stove and fireplace insert projects are not eligible for reimbursement without a dated receipt from a dismantling/recycling facility.
- I understand that I will need to provide photographic proof throughout the wood-burning fireplace decommissioning process, from start to finish. The photos must clearly shows all steps taken and I agree to submit these photos with the claim for payment packet.
